Parent/Guardian:

I understand that Internet access is designed for educational purposes. Clearview Regional High School District has taken precautions to eliminate controversial material. However, I also recognize it is impossible for Clearview Regional High School District to restrict access to all controversial materials, and I will not hold them responsible for materials acquired on the network. I understand that the display or transmission (E-Mail and files) of pornographic materials, hate mail, harassment, discriminatory remarks, and other antisocial behavior, including ethnic slurs and racial epithets, is prohibited. Further, I accept full responsibility for supervision, if and when my child's use is not in a school setting. I hereby give permission for my child to access the Internet, and certify that the information contained on the form is correct.

Furthermore, I hereby grant permission for my child's work to be posted to the district Web site. I understand that all work posted to the district Web site is available for inspection by users of the World Wide Web.

Student: As a student of the Clearview Regional High School District, I have read the Internet Use Policy located on the district's website and will abide by its guidelines. I understand that the display or transmission (E-Mail and files) of pornographic materials, hate mail, harassment, discriminatory remarks, and other antisocial behavior, including ethnic slurs or racial epithets, is prohibited. I further understand that any violation of the above regulations is unethical, and may constitute a criminal offense. If it is found that a violation was committed, my access privileges may be revoked, I may be subjected to school disciplinary action, and/or appropriate legal action, may be taken.

Furthermore, I hereby grant permission for my work to be posted to the district Web site. I understand that all work posted to the district Web site is available for inspection by users of the World Wide Web.

Personal Device Use

Clearview Regional High School District students will be permitted to bring in their personal devices for use in school as long as students adhere to the district policies and regulations.

Student personal laptops, notebooks, ultra books, netbooks, tablets, iPads/iPods, e-readers and cell/smart phones (hereinafter collectively referred to as "devices") will be provided filtered access to the Internet as well as access to any network applications (i.e. Sharepoint, Microsoft Office, Student Network Data) that would normally be accessible to students on a district owned computer, subject to the procedures and requirements contained herein. Devices are valuable electronics that can be damaged. The Clearview Regional School District (hereinafter "District") is not responsible for the loss, theft and/or damage of a personal device(s). Neither shall the District be liable for any unauthorized access to the device or the data that resides therein. In addition:

1. Students will be permitted to use devices in their designated classrooms at their teacher's discretion based upon the educational appropriateness of such usage.
2. Students are responsible for their device set-up, maintenance, and security. Students are responsible to store their devices in secured lockers when not in use. Teachers will not store student devices at any time. District personnel will NOT provide maintenance for any personal devices.

3. Devices must run on the battery only. The District will not provide electrical outlets for the students to use to charge their devices.
4. No gaming, chatting, myspace, facebook, tweeting, social networking, downloading of music and/or movies, listening to music, viewing movies and/or any other usage of the devices for any non-educational purposes shall be permitted. Use of the devices is for educational purposes only. The use must be approved by the teacher and can only be in designated locations. This includes use before and after school, as well as during school hours.
5. Device sound must be turned off at all times. Headphones may be used if approved by the instructor.
6. The teacher will determine when devices will be utilized in their classroom, based upon the educational appropriateness of such usage and will monitor the students' access in the classroom.
7. Student use of the district network shall be monitored when on and off campus. The student should not have a reasonable expectation of privacy when student devices are utilized on campus.
8. Students can only use the CRHS Guest wireless network which is monitored by the district at all times. Students are not permitted to bring in any type wireless access point devices to create their own wireless network, including turning their phone into a Wi-Fi Hotspot. Students' devices are required to be "Wi-Fi" capable in order to participate in this program.
9. The District's expectation is that the campus network will be used exclusively for educational purposes.
10. The District's expectation is that students will use educationally appropriate speech and expression when using the internet and other technological tools.
11. The student is responsible to avoid copyright violations.
12. It is the students' responsibility to avoid substantial and material disruption of the education process for the school community.
13. If a student uses a personal device(s) in an inappropriate manner and/or in violation of the Procedures outlined above and/or the District's Acceptable Use Policy and Regulation 2361, they will lose their privilege of bringing a personal device to school. Devices may be confiscated and the contents thereof examined should any District personnel have a reasonable suspicion that the student's use of the devices is in violation of either or both the Procedures outlined above and/or the District's Acceptable Use Policy and Regulation 2361.
14. Students must abide by the Acceptable Use Policy and Regulation 2361 and Pupil Use of Privately Owned Technology Regulation 2363 and applicable laws as adopted by the Clearview Regional School District Board of Education.

CONSEQUENCES FOR INAPPROPRIATE USE SHALL INCLUDE BUT NOT BE LIMITED TO THE FOLLOWING:

- Loss of privilege to bring the device to campus.
- Suspension of access to the District's computer network;
- Revocation of the District's computer network system account(s); and/or
- Other appropriate disciplinary or legal action in accordance with the **Acceptable Use Policy and Regulation 2361, the Pupil Use of Privately Owned Technology Regulation 2363 and applicable laws.**

NOTE: The student agreement to abide by these guidelines must be renewed each academic year.
